






### Total Inflation-Adjusted (Real) Expenditures Per Student Increased 41% in U.S. Public Schools 1992 to 2018




# NAEP Long-Term Trend Reading and Math Scores 1992 and 2008 (17-year olds)




# NAEP Long-Term Trend Reading and Math Scores 2008 and 2012 (17-year olds)




## New Hampshire State Funding for Public School and Education Freedom Account Students, 2019-20


# When a child leaves a public school for any reason (moves to another district, open enrollment, choice, etc.)

- The local districts retain all locally generated funds (e.g. property taxes, etc.)
- The districts lose most state funds
- The districts retain most federal funds
  - No other enterprise in America gets to retain funds for customers they lose




# Number of Indiana Choice Scholarships Awarded, 2012 to 2020




# Indiana Public School District Staffing Surge, 2012 to 2016

# Real Changes in Total Debt, Cash and Securities 2011 to 2016




# New Hampshire Public School Spending and Education Freedom Accounts (EFAs), 2019-20

# New Hampshire's Education Freedom Account (EFA) Program is Interesting

- <u>All</u> children living in households earning less than 300% of the federal poverty line are eligible. <u>All</u>—includes public, private, and homeschool students.
- Most homeschool students and a significant percentage of private school students will not use NH's EFA program.
  - Homeschool families often want to be left alone
  - Not all eligible people take-up government benefits (Indiana Choice Scholarship Program, Pell Grants for College, etc.)

The scholarships will be offered to all private school students, but history suggests many will not accept.

- Scholarships to students who would have attended a private school, even without an EdChoice program, are a fiscal cost.
  - These costs must be weighed against the substantial fiscal savings that result from families choosing to switch their children from a public to a private school via the EdChoice program.
- I estimate that New Hampshire taxpayers will save \$1.85 million next year and \$4.8 million in year 2 in net fiscal savings.
