ECCHOICE Definition

School choice allows public education funds to follow students to the schools or services that best fit their needs—whether that's to a public school, private school, charter school, home school or any other learning environment parents choose for their kids.

SCHOOL CHOICE PROGRAMS

Education Savings Accounts (ESAs)

ESAs allow parents to withdraw their children from public district or charter schools and receive a deposit of public funds into government-authorized savings accounts with restricted, but multiple, uses. Those funds—often distributed to families via debit card—can cover private school tuition and fees, online learning programs, private tutoring, community college costs, higher education expenses and other approved customized learning services and materials. Some ESAs, but not all, even allow students to use their funds to pay for a combination of public school courses and private services.

School Vouchers

Vouchers give parents the freedom to choose a private school for their children, using all or part of the public funding set aside for their children's education. Under such a program, funds typically expended by a school district would be allocated to a participating family in the form of a voucher to pay partial or full tuition for their child's private school, including both religious and non-religious options.




School Vouchers





WHAT IS A TAX-CREDIT SCHOLARSHIP?


Individual Tax Credits & Deductions

Individual tax credits and deductions allow families to receive state income tax relief for approved educational expenses, which can include private school tuition, books, supplies, computers, tutors and transportation. Tax credits lower the total taxes a person owes; a deduction reduces a person's total taxable income. Individual Tax Credits & Deductions



Ohio enacted and launched its Income-Based Scholarship Program in 2013. It offers private school vouchers to students from low- and lower middle-income households. Continue reading to learn more about this program's funding, eligibility, regulations, governing statutes, and more.	The Jon Peterson Special Needs Scholarship was enacted in 2011 and launched in 2012. It provides school vouchers to Ohio students with special needs to cover private school tuition and other educational services covered by their Individual Education Plans (IEPs). The Ohio Department of Education sets school voucher limits for different types of disabilities, so funding and eligibility vary. Learn more about that, regulations, and more on this page.	Ohio's "EdChoice" scholarship program, enacted in 2005 and launched in 2006, offers private school vouchers to K–12 students who are assigned to "low-performing" public schools. Participating private schools are required to accept the voucher as full tuition for students whose families are at or below 200 percent of the federal poverty level. Tax-Credit Scholarship

Florida – Hope Scholarship Program

This program allows purchasers of motor vehicles to contribute their vehicle sales tax to fund private school scholarships. Hope Scholarships may be used by students who are victims of bullying or are physically attacked in school. These students may also transfer to other public school districts. Florida – Gardiner Scholarship Program

Florida's Gardiner Scholarship Program allows students with special needs an opportunity to receive an education savings account (ESA) funded by the state and administered by an approved scholarship funding organization. Parents can use the funds to pay for a variety of educational services, including private school tuition, tutoring, online education, home education, curriculum, therapy, postsecondary educational institutions in Florida and other defined educational services.
